FOR MYSELF, AND ON BEHALF OF MY HEIRS, THOSE ASSIGNED AS A PERSONAL REPRESENTATIVE, AND NEXT OF KIN, HEREBY: RELEASE, HOLD HARMLESS AND PROMISE NOT TO SUE THE EUROPEAN BOXING FEDERATION, OR THEIR OFFICERS, VOLUNTEERS, STAFF, OR SPONSORS. FURTHER I AND/OR MY PARENT/GUARDIAN "RELEASES" LIABILITY OF ANY OF THE FORE MENTIONED TO ANY AND ALL INJURY AND LOSS ARISING FROM MY PARTICIPATION, WHETHER CAUSED BY NEGLIGENCE OR OTHERWISE, EXCEPT THAT WHICH IS THE RESULT OF GROSS NEGLIGENCE OR WANTON MISCONDUCT.
